The Mortgage Society of Finland's bank subsidiary Suomen AsuntoHypoPankki Oy raises its Hypo Prime rate by 0.10 percentage points to 0.15 percent. The increase is based on the development of general market rates.

The rate change is effective as of 15 August 2022. In practice, only Group's deposit clients whose deposits have Hypo Prime as the reference rate will be affected.
